- ⇒ Due upon registration for each child: “Completed” membership packet (with required documents) and a \$130 payment towards the total amount due (includes a non-refundable \$75 deposit per child).
- ⇒ All outstanding balances must be paid no later than 5/4/17. Your child is not officially registered until all payments have been received.
- ⇒ Payment plans available — If a payment plan is requested, you must pay “at least” \$50 bi-weekly to keep your child’s “reserved” space. No payment plans offered after March 30, 2017. Final payment still due on 5/4/17.
- ⇒ Parents “may” have to provide lunches and snacks. Swimming fees are an additional charge.
